WOODBINE MUNICIPAL UTILITIES AUTHORITY MEETING MINUTES April 27, 2015

The meeting was called to order by Chairman, William Pikolycky at 7:33 p.m.

UNFINISHED BUSINESS:

USDA/Sewer Study Status Update

Engineer Graham reported that there was nothing new, and that he was just waiting for information regarding the \$40,000.00 from the USDA grant application that had been submitted. He also stated that he was still in communications with the Department of Human Services regarding participation of the Woodbine Developmental Center. Chairman Pikolycky commented on this matter.

Water Tower Renovations

Engineer Graham reported that the water tower was complete, and were now in the process of having the antennas go back up without damage to the newly painted tower. He stated that he was waiting on some paperwork from the contractor. The change order was briefly discussed.

Chlorine Room - Flood Damage

Engineer Graham reported that he put together a preliminary estimate of the cost to fix the Chlorine Room, and hoped to put it out to bid soon. He stated that this would replace the chlorinator and also the electrical panel. Solicitor Blaney gave information regarding this matter. Engineer Graham stated that he had not yet heard back from the insurance company. Chairman Pikolycky questioned what should be expected next. Engineer Graham addressed his question. Solicitor Blaney recommended that an action naming everyone involved should be done if the insurance does not cover all the cost. Chairman Pikolycky questioned regarding a possible alarm system. Engineer Graham addressed his questioned, and stated he would follow up by the end of the week. A brief discussion was initiated regarding this matter.

ENGINEER'S REPORT:

Engineer Graham continued the meeting by reporting on road projects in certain parts of the Borough.

WATER OPERATIONS:

Jim Gurdgiel reported that an OSHA inspection was done, and he stated before the Board what was being done to comply with the inspection requirements. He explained that a DEP discharge permit inspection was also done. He stated that the back wash pond needed to be cleaned. He stated that a sixty (60) day plan of action was needed as of March 30, 2015. Chairman Pikolycky stated that the first thing needed to be done was to cut the grass and clean up the area. A discussion was initiated regarding this matter. Engineer Graham recommended that if Mr. Gurdgiel needed more time to meet OSHA requirements, that he should notify them.

SEWER OPERATIONS:

Mr. Lynch reported that the heaters had been turned off, and that this should bring the electrical cost down.

SOLICITOR'S REPORT:

Chairman Pikolycky questioned Mr. Blaney regarding any correspondence from AT & T. Mr. Blaney reported that he had not heard anything for approximately three (3) months now. The NJ Start forms that were sent from the Woodbine Developmental Center, and also requested from the Belleplain State Forest Representatives were discussed.

At this time, Chairman Pikolycky initiated a discussion regarding current salaries for employee's Jose Gomez and Chuck Becica. Mr. Gurdgiel addressed his questions. Mr. Gurdgiel mentioned that Mr. Gomez had questioned the possibility of becoming a full-time employee with benefits. Insurance for Mr. Gomez was also discussed. Solicitor Blaney recommended that resolutions be done. A discussion was initiated as to what would be inserted in the resolution for each employee. After said discussion, a motion was made and seconded to approval the new salaries for each employee as follows:
