### BOROUGH OF WOODBINE REGULAR MEETING

# MAY 21, 2015 8:00 P.M.

Mayor Pikolycky called the Regular Meeting to order and read the following statement, "Adequate notice of this meeting was provided in compliance with the Open Public Meetings Act by notifying The Herald on January 20, 2015 and posting a copy of said notice on the Clerk's bulletin board."

Those present were: Mayor Pikolycky; Councilmen Bennett, Benson and Cruz. Also present were: Richard Tonetta, Borough Solicitor; Bruce Graham, Borough Engineer; and Lisa Garrison, Borough Clerk. Absent: Councilpersons Ortiz, Murray and Perez.

Mayor Pikolycky called for the Pledge of Allegiance.

Mayor Pikolycky called for approval of the minutes of May 7, 2015 (workshop & regular). On motion of Councilman Cruz, seconded by Councilman Bennett to approve the minutes of May 7, 2015 as presented, unanimously.

Mayor Pikolycky called for the following resolution:

# **RESOLUTION NO. 5–60-2015**

## ACCEPTANCE OF PROJECT EMS BUILDING UPGRADES

**WHEREAS,** Turtle Associates, LLC of Swedesboro, New Jersey was previously awarded a contract for the project known as EMS Building Upgrades; and

**WHEREAS**, the Borough Engineer, Bruce S. Graham of Van Note-Harvey Associates, has determined that the work on this project has been substantially completed in accordance with the contract documents.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Woodbine, that the contract for the work be and same is hereby accepted as substantially complete, and

**BE IT FURTHER RESOLVED** that upon certification from the Borough Engineer that all final project closeout requirements for the contract have been satisfied, that payment as previously authorized by contract through and including approved change order no. 4 be made thereon to Turtle Associates, LLC.

On motion of Councilman Bennett, seconded by Councilman Benson to approve and

adopt the foregoing resolution, unanimously carried.

### Unfinished Business:

Vacant Properties (Abandoned and/or Absentee Owners) – Status – Mr. Tonetta indicated he will meet with the Clerk to review the procedures. Ms. Garrison indicated sixty-nine (69) letters were sent out to property owners in regards to property maintenance. Mayor Pikolycky indicated it is becoming burdensome to the Borough to maintain these properties. Mayor Pikolycky indicated he has received feedback regarding the letters being sent out are aggressive. Council reviewed the letter and indicated it was not overly aggressive and advised the property owner of the repercussions of failing to comply.

Trash & Recycling Collection Rules & Regulations - Councilman Bennett will be coordinating with Public Works.

COAH – Status - Mr. Tonetta indicated July 8 the declaratory action must be filed with the court and recommended the need for a planner's assistance. He will reach out to Triad Associates.

Public Safety & Courts: Chairman Cruz reported a meeting had been held with himself, the Mayor and the Fire Company in regards to the fire reimbursement program.

Community Affairs: Chairman Ortiz was absent.

Property & Small Business: Chairman Murray was absent.

Revenue & Finance: Chairwoman Perez was absent.
