RESOLUTION NO. 7-50-2016

A RESOLUTION ACCEPTING A GRANT FROM THE HAZARDOUS DISCHARGE SITE REMEDIATION FUND PUBLIC ENTITY PROGRAM THROUGH THE NEW JERSEY ECONOMIC DEVELOPMENT AUTHORITY AND THE DEPARTMENT OF ENVIRONMENTAL PROTECTION

WHEREAS, the Borough of Woodbine has applied for and has been awarded a grant in the amount of \$69,583 from the Hazardous Discharge Site Remediation Fund Municipal Grant Program through the Department of Environmental Protection and the New Jersey Economic Development Authority for the Remedial Investigation along with report preparation of the Woodbine Hat Company property;

NOW, THEREFORE, BE IT RESOLVED by the governing body of the Borough of Woodbine that the above referenced grant is hereby accepted and the Mayor is hereby authorized to execute grant documents as an authorized representative thereunder, as the representative for the Borough of Woodbine.

RESOLUTION NO. 7-51-2016

PROVIDING FOR THE INSERTION OF A SPECIAL ITEM OF REVENUE IN THE BUDGET PURSUANT TO N.J.S.A. 40A:4-87

WHEREAS, N.J.S.A. 40A:4-87 provides that the Director of Local Government Services may approve the insertion of any special item of revenue in the budget when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

RESOLUTION NO. 7-55-2016

RESOLUTION AUTHORIZING THE EXECUTION OF A SHARED SERVICES AGREEMENT WITH THE COUNTY OF CAPE MAY FOR THE DEHIRSCH AVE (COUNTY ROUTE 550) IMPROVEMENTS

WHEREAS, the County of Cape May is proceeding with a project in the Borough of Woodbine to improve North De Hirsch Avenue (County Route 550) from Madison Avenue to just west of Scott Avenue; and

WHEREAS, the Borough of Woodbine is proceeding with a project to make resurfacing improvements to South De Hirsch Avenue from Washington Avenue to Madison Avenue; and

WHEREAS, the Borough's improvement project is similar to the County's improvement project; and

WHEREAS, North De Hirsch Avenue is under the jurisdiction of the county and is maintained by the County; and

WHEREAS, South De Hirsch Avenue is under the Jurisdiction of the Borough and is maintained by the Borough; and

WHEREAS, it is advantageous from a cost perspective, coordination of traffic control during the construction phase and the quality of life of the adjacent property owners do not suffer as long by combining the two (2) roadway improvements as one (1) jointly shared construction project; and

WHEREAS, the Borough and County have indicated a willingness to work together for an efficient and coordinated Project; and

WHEREAS, under the Shared Services Act, any local unit may enter into an agreement with any other local unit or units to provide and/or receive any service that each local unit participating in the agreement is empowered to provide or receive within its own jurisdiction, including services incidental to the primary purposes of any of the participating local units; and

NOW, THEREFORE, BE IT RESOLVED by the Borough of Woodbine, as follows:

1. The Borough of Woodbine hereby approves the Shared Services Agreement Between the Borough of Woodbine and the County of Cape May to jointly conduct the Project with the County acting as the lead agency.

2. The Mayor is authorized to execute said Agreement.

RESOLUTION NO. 7-56-2016

A RESOLUTION AUTHORIZING REDEMPTION OF PROPERTY KNOWN AS BLOCK 32 LOT 7 AND 8 IN THE BOROUGH OF WOODBINE

WHEREAS, the Boroughs of Woodbine holds a Certificate of Sale No.: 16-0008 for property known as Block 32 Lot 7 and Certificate of Sale No.: 16-0009 for property known as Block 32 Lot 8 on the Tax Map of the Borough of Woodbine and the amount necessary to redeem totals \$6,547.57 on Block 32 Lot 7 and \$49,943.02 on Block 32 Lot 8 including interest calculated up and including August 11, 2016 on property owned by Michael Rutowski whose address is 412 Joffe Drive, Woodbine, NJ (owner). The total necessary to redeem both properties is \$56,490.59 which includes the 3rd quarter interest and penalties; and

WHEREAS, the Owner has requested the Borough consider installment payments to redeem said properties as of August 11, 2016; and

WHEREAS, N.J.S.A. 54:5-65 et seq authorizes such installment payments and Borough Council finds it to be in the best interest of the Borough to allow installment payments provided the installment payments are to redeem both Lot(s) 7 and 8 of Block 32; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of Woodbine as follows:

1. The Tax Collector is hereby authorized and directed to accept installment payments in redemption of total arrears and accrued interest for both Lot(s) 7 and 8 of Block 32. Failure to make installment payments as hereinafter set forth shall be an event of Default and terminate this agreement.

2. The following payment schedule shall be adhered to:

A) On or before August 11, 2016 the Owner, his agent or assigns shall pay the sum of \$30,000.00 of which \$6,547.57 shall be applied to Lot 7 and \$23,452.43 shall be applied to Lot 8.

B) The balance of principal and interest due on Lot 8 shall be \$26,490.59 up to and including August 11, 2016.

■ Interest shall accumulate on the unpaid principal amount at a rate of 18% per annum.

• The Owner shall make 36 monthly payments of principal and interest in the amount of \$957.70 consisting for Block 32 Lot 8..

The First payment of principal and interest shall be made on or before September 11, 2016 and all subsequent payments shall be made on or before the 11th day of each month

thereafter until paid in full in accordance with the mortgage schedules attached hereto and made a part hereof.

• Default in any installment payment terminates this Agreement and subjects the property to foreclosure action.

All taxes not yet due shall be regularly and properly made.

In addition to the payments set forth herein above. Failure to make any future tax payments when due shall be an event of default under this Agreement.

BE IT FURTHER RESOLVED that should any portion of this Resolution be deemed unenforceable the balance of the Resolution shall remain in full force and effect.

AWARD OF CONTRACT FOR MUNICIPAL BUILDING EMERGENCY GENERATOR

WHEREAS, sealed bids were received on July 7, 2016 by the Borough for the construction of the project known as the "Municipal Building Emergency Generator"; and

WHEREAS, R. Janney Electric, Inc. of Estell Manor, NJ submitted the lowest of three (3) bids received for the project which are summarized as follows:

WHEREAS, the Borough has received approval for a FEMA grant from the NJ Office of Emergency Management in the amount of \$75,000.00 for the overall project and the balance of funds required are anticipated to be provided in cooperation with the Woodbine Municipal Utilities Authority; and

WHEREAS, the bid of R. Janney, Inc. has been submitted in proper form and the Contractor appears qualified to perform the work anticipated under this contract;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Woodbine, that the award of said contract is hereby made to R. Janney, Inc. in the amount of \$80,462.50, said award being subject to certification that sufficient funds are available for the award; and

BE IT FURTHER RESOLVED that the Municipal Clerk is hereby authorized and directed to return the certified checks or bid bonds for the following unsuccessful bidders:

Multi-Temp Mechanical, Inc.

and that the certified checks or bid bonds of the successful bidder (R. Janney Electric, Inc.) and the next lowest bidder (Scalfo Electric, Inc.) are to be returned upon receipt of a fully executed Contract and other required documents.

BE IT FURTHER RESOLVED that upon certification of funds, the Mayor and Clerk are hereby authorized to execute all documents necessary to effectuate a contract with R. Janney Electric, Inc. for this project.
