RESOLUTION NO. 9-117-2017

APPOINTMENT OF MUNICIPAL ALLIANCE COORDINATOR

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse was established by the New Jersey legislature in March of 1989 to coordinate all State Departments efforts to the planning and provision of prevention, education, treatment, research and evaluation services for, and public awareness of, alcoholism and drug abuse; and

WHEREAS, the legislation also created the Alliance to Prevent Alcoholism and Drug Abuse to be comprised of all the communities in New Jersey dedicated to a comprehensive and coordinated effort against alcoholism and drug abuse through the use of funds provided and derived pursuant to N.J.S.A. 2C:35-15, to member communities to support appropriate county and/or municipal based alcohol and drug abuse education and public awareness activities; and

WHEREAS, there currently exists a vacancy in the position of Municipal Alliance Coordinator; and

WHEREAS, the Mayor and Council believe it to be in the best interest of the Borough of Woodbine to appoint a Municipal Alliance Coordinator.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of Woodbine to appoint Rose Hudgins to the position of Municipal Alliance Coordinator as of September 7, 2017 and to be paid an annual stipend of \$1,000.00 to be paid quarterly through the Municipal Alliance Grant.
