#### **2018 GREEN COMMUNITIES**

**WHEREAS**, the governing body of the Borough of Woodbine desires to further the public interest by obtaining a grant from the State of New Jersey in the amount of approximately \$3,000.00 to fund the following project:

Community Forestry Management Plan 2018 Green Communities Grant

- **NOW, THEREFORE, BE IT RESOLVED** that William Pikolycky or the successor to the office of Mayor is authorized (a) to make application for such a grant, (b) if awarded, to execute a grant agreement with the State for a grant in an amount not less than \$3,000.00 and not more than \$3,000.00, and (c) to execute any amendments thereto which do not increase the Grantee's obligations.
- **BE IT FURTHER RESOLVED** that the Borough Council authorizes and hereby agrees to match 33.3% of the Total Project Amount, in compliance with the match requirements of the agreement. The availability of the match for such purposes, whether cash, services, or property, is hereby certified. 100% of the match will be made up of in-kind services
- **BE IT FURTHER RESOLVED** the Grantee agrees to comply with all applicable federal, State, and municipal laws, rules, and regulations in its performance pursuant to the

agreement.
