### BOROUGH OF WOODBINE REGULAR MEETING

### NOVEMBER 1, 2018 8:00 P.M.

Mayor Pikolycky called the Regular Meeting to order and read the following statement, "Adequate notice of this meeting was provided in compliance with the Open Public Meetings Act by notifying the Press and The Herald on January 23, 2018 and posting a copy of said notice on the Clerk's bulletin board."

The Pledge of Allegiance was led by Mayor Pikolycky.

Mayor Pikolycky called for approval of the minutes. On motion of Councilman Cruz, seconded by Councilman Bennett to approve the minutes of October 4, 2018, unanimously carried.

### **RESOLUTION NO. 11-100-2018**

### APPROVAL OF CHANGE ORDER NO. 2 FIRE TRUCK PURCHASE

**WHEREAS**, Rosenbauer South Dakota, LLC of South Dakota was previously awarded a contract in the amount of \$443,043.00 for the purchase of a 2018 Rosenbauer Pumper Apparatus; and

WHEREAS certain additions and deletions to the scope of work were incorporated into the agreement; and

WHEREAS, said additions and deletions are as shown on Change Order No. 2 increasing the contract amount by \$1,350.00 and when combined with Change Order No. 1 making the total amended contract amount \$454,393.00; and

WHEREAS, the necessary funds for this contract modification are available; and

WHEREAS, Lisa Garrison, Borough Clerk recommends approval of said Change Order No. 2.

# A RESOLUTION OF THE BOROUGH OF WOODBINE IMPLEMENTING A FAIR AND OPEN PROCESS FOR THE SELECTION OF BOROUGH ENGINEER, SOLICITOR, AUDITOR, GRANT APPLICATION AND MANAGEMENT CONSULTANT SERVICES AND AIRPORT ENGINEER

**WHEREAS**, the Borough Council of the Borough of Woodbine acknowledges the need for Professional Services to be provided to the Borough; and

**WHEREAS**, the Borough Council recognizes the need to implement the requirements of N.J.S.A. 19:44A-20.5 so as to have a fair and open procedure for awarding professional service agreements which would otherwise be exempt from public bidding in accordance with N.J.S.A. 40A:11-5; and

**WHEREAS**, the Borough Council believes it is in the best interest of the Borough to select professionals to provide services to the Borough primarily on the basis of their qualifications, including qualifications uniquely suited to the needs of the Borough of Woodbine; and

**WHEREAS,** to receive statements of qualifications in a manner that fosters a fair and open process, it is necessary and advisable to establish advance general criteria and specific minimum requirements; and

**WHEREAS,** the Borough Council has determined that a fair and open process requires public advertisement of professional services required in a manner and with sufficient time to provide notice in advance of the contemplation of retaining services of a professional and the criteria to be considered in determining the best professional for the position; and

**WHEREAS,** a fair and open process requires that all responses be publicly opened and announced and thereafter that all appointments be made at a public meeting of the Borough of Woodbine as follows:

- 1. All appointments for Professional Services contained on Schedule "A" attached to and made a part hereof shall be subject to a fair and open process as set forth below.
- 2. The Borough Clerk shall cause all legal notices stating that a full listing of the professional service appointments subject to a fair and open process together with the criteria established for the consideration of qualification, will be posted on the Borough of Woodbine's internet website beginning no later than November 16, 2018.
- 3. The criteria for each position contained on Schedule "A" follows immediately subsequent to the Listing on Schedule "A". The criteria shall be disclosed together with the posting of the listed positions on the Borough of Woodbine's internet website as set forth above.
- 4. The website posting shall inform potential applicants that all submissions must be made to the Clerk of the Borough of Woodbine and received no later than 3:00 p.m. December 14, 2018.
- 5. Commencing 3:01 p.m. on December 14, 2018, or as soon thereafter as may be available, the Clerk of the Borough of Woodbine or her designee shall publicly open and announce all submissions in the Borough Council chambers, 501 Washington Avenue, Woodbine, New Jersey.
- 6. Appointments shall thereafter be made at a public meeting of the Borough Council of the Borough of Woodbine.
- 7. Subsequent to appointments, appropriate notices shall be published in accordance with the requirements of N.J.S.A. 40A:11-5.

**WHEREAS**, from time to time tenants of the Woodbine Airport become delinquent in the payment of rent or breach other terms of the lease agreements entered between the Borough of Woodbine and the tenant; and

WHEREAS, in order to provide proper services to patrons of the Woodbine Airport, it is incumbent upon the Borough to assure that all sums of money due the Borough is properly collected in accordance with the terms of the lease agreements and time being of the essence; and

WHEREAS, the Council of the Borough of Woodbine finds that authorizing the Borough Clerk, Mayor and Solicitor to seek collection and/or eviction of tenants who have

breached their hangar lease agreements will allow for an expedited collection practice.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Borough of Woodbine that the Mayor and Solicitor are authorized to pursue collection and/or eviction of any tenant of the Woodbine Municipal Airport in accordance with the lease agreements, including any and all court actions and the Borough Clerk, Mayor and Solicitor are authorized to execute any documents necessary to enforce the terms of said lease agreements.

WHEREAS, the New Jersey Department of Environmental Protection, Division of Parks and Forestry (NJDEP) is the administrator of Block 219 Lot 21 located in the Borough of Woodbine as part of the Bellplain State Forest (Property); and

**WHEREAS**, the Property is located in the vicinity of the boundaries of the former Woodbine Landfill located on Fidler Hill Road, Block 117 Lot 1 on the Borough Tax Map; and

WHEREAS, NJDEP has notified the Borough of its obligation to investigate and, if necessary, remediate any environmental problems that may exist at or near the Property and therefore the Borough will be required to install groundwater monitoring wells on the Property to adequately investigate any environmental concerns thereon; and

**WHEREAS**, in order to install groundwater monitoring wells, the Borough has requested access to the Property from the NJDEP which has been granted subject to the execution of a Right of Entry Agreement in the form and substance substantially similar to that as attached hereto marked Exhibit A.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Borough of Woodbine that the Mayor and Clerk are hereby authorized to execute a Right of Entry Agreement with the New Jersey Department of Environmental Protection, Division of Parks and Forestry in the form and substance substantially similar to Exhibit A attached hereto.
