AUTHORIZING REDEMPTION IN INSTALLMENTS

WHEREAS, N.J.S.A. 54:5-65 provides authority for the governing body to authorize redemption of a municipally held lien by installment payments to include principal and interest; and

WHEREAS, John Feeney, owner of record of Block 112 Lot 3 C-154, also known as 154 Ivy Street, Borough of Woodbine, is desirous of satisfying Tax Title Lien #16-00039 by the installment payment plan.

NOW, THEREFORE, BE IT RESOLVED, that the Governing Body of the Borough of Woodbine, County of Cape May, State of New Jersey, hereby authorize an installment plan as set forth on the attached schedule and that in addition to said installments being promptly paid on the first of each month, for up to 36 months, all current year's taxes, subsequent taxes, assessments or other municipal liens imposed shall be promptly paid when due.

BE IT FURTHER RESOLVED, if any unpaid installment remains unpaid after 30 days of due date, then the municipality may proceed to enforce or foreclose the tax sale lien, or sell, assign, transfer or alienate it and shall proceed only for the unpaid balance after proper credit of such installment payments as were made.

BE IT FURTHER RESOLVED, that a certified copy of this resolution, along with an attached installment schedule will be forwarded to the Tax Collector and the property owner.

- 3. Disclosure of the minutes of the closed meeting authorized above between the Borough Council, the Mayor, Borough Clerk and staff, Borough Solicitor and staff, Borough Special Counsel Mitchell Kizner and staff, Borough Engineer and staff, Borough Airport Engineer and staff shall be made following final negotiations and determination of said matter excepting information which must remain private.

RESOLUTION NO. 12-150-2017

RESOLUTION AUTHORZIING EXECUTION OF A HOST COMMUNITY BENEFIT AGREEMENT WITH THE CAPE MAY COUNTY MUNICIPAL UTILITIES AUTHORITY

WHEREAS, the Cape May County Municipal Utilities Authority (hereinafter CMCMUA operates a solid waste complex located on the border of the Borough of Woodbine and the Township of Upper, in Cape May County, New Jersey; and

WHEREAS, said solid waste complex has been sited as said location pursuant to the Solid Waste Management Plan of Cape May County adopted by the Board of Chosen Freeholders and approved by the New Jersey Department of Environmental Protection; and **WHEREAS**, Woodbine is a host community for the Authority's solid waste complex; and

WHEREAS, New Jersey Statutes (N.J.S.A. 13:1E-28) provide that a municipality within which an approved solid waste facility is located shall be entitled to an annual economic benefit in consideration of the amount of solid waste accepted for transfer or disposal at said facility; and

WHEREAS, Woodbine and the CMCMUA have previously entered into various Agreements dated January 21, 1993, May 16, 1997; February 24, 2005; and December 11, 2011 regarding an annual host community benefit to be paid by the CMCMUA to Woodbine, for serving as a host community for the Authority's solid waste complex; and

WHEREAS, the minimum tonnage provision of the Agreement will guarantee an annual revenue to the Borough of \$400,000; and

WHEREAS, Woodbine desires to maintain its current economic host community benefit; and

WHEREAS, the CMCMUA desires to continue to provide affordable long-term solid waste disposal and recycling services for all municipalities and businesses located within Cape May County; and

WHEREAS, the Authority and the Borough of Woodbine desire the continuation of the current economic host community benefit to the Borough of Woodbine, which serves as a host community for the Authority's landfilling and recycling operations through the year 2023 in accordance with the terms of an agreement, a copy of which is attached and made a part hereof.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Woodbine, in the County of Cape May and State of New Jersey, as follows:

- 1. The statements of the preamble are incorporated herein by this reference.
- 2. The Mayor and Borough Clerk be and they are hereby authorized to execute on behalf of the Borough of Woodbine the attached Host Community Benefit Agreement and to take such other measures as are reasonably necessary and appropriate for the implementation of the subject agreement.

WHEREAS, N.J.S.A. 40:65-1 et seq., the Uniform Shared Services and Consolidation Act ("Act"), authorizes municipalities to enter into agreements with other municipalities and/or counties for the joint provision within, their jurisdictions of services which any of the parties on whose behalf such services are to be performed may legally perform for itself; and

WHEREAS, the Cape May County Municipal Utilities Authority (the "Authority") owns various equipment and employs a variety of personnel to provide facility maintenance and related services; and

WHEREAS, the Borough of Woodbine may, in emergency situations, as declared by local, county or state officials, require the use of the equipment, material, supplies and personnel provided by the Authority; and

WHEREAS, the Borough of Woodbine recognizes that the use of the Authority equipment, material, supplies and personnel could be economically beneficial to the Borough; and

WHEREAS, it has been determined by the Mayor and Borough Council of the Borough of Woodbine that it would be in the best interest of the citizens of the Borough to enter into a shared services agreement with the Cape May County Municipal Utilities Authority for a Mutual Aid Agreement and Assistance Program.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Woodbine, Cape May County, New Jersey, as follows:

- 1. The allegations of the preamble are incorporated herein as if set forth in full.
- 2. The Mayor and Clerk of the Borough of Woodbine shall be, and hereby are, authorized, empowered and directed to enter into a shared service agreement with the Cape May County Municipal Utilities Authority for a mutual aid agreement and assistance program in a form substantially conforming to the Agreement annexed hereto as Exhibit "A".
- 3. A certified copy of this Resolution and two (2) copies of the attached Agreement shall be provided forthwith to the Cape May County Municipal Utilities Authority.
